A regular meeting of the Village of Freeville Board of Trustees was held on September 6, 2016, at the Village Hall.

Call to Order: Mayor Fogel called the meeting to order at 7:34 pm

Privilege of the Floor: Suzanne McMannis from Weaver Wind Energy brought by a copy of Sept/Oct 2016 Home Power magazine. Cover story is of William Bassett who owns a farm near Ithaca, NY. He runs the farm house on solar and wind turbine designed by Weaver Wind Energy. They've stopped using the lawn mowing service and plan to get a battery operated electric mower. They also talked about getting sheep to take care of the lawn. Since this is currently against Village ordinance they thought about bringing sheep in for the day from a farm outside the Village. They've asked if they could manage the mowing of the rail bed adjacent to their property. This would prevent noise and lessen the use of fossil fuel. They will not be compensated but are welcome to maintain the adjoining village property.

Dan Lamb was shown the pocket diorama. Favorable momentum developing on recreational trail from Ithaca to Dryden. Discussion on how to get to from Union Street to DPW Drive without having to go onto Rt 38. (RR St)
