VILLAGE OF FREEVILLE BOARD OF TRUSTEES MEETING MINUTES September 5, 2023

A regular meeting of the Village of Freeville Board of Trustees was held on September 5, 2023, at the Village Hall.

Call to Order: Mayor McCarty called the meeting to order at 7:30 pm

Privilege of the Floor: Zoning Board Chairman Michael Whalen spoke regarding an application for a solar array and its relation to the Land Use Law and the Village's Local Law #2 of 2017 Solar and Wind Energy. Chairman Whalen suggested that the Board consider incorporating Local Law #2 into the Village's Land Use Code. Discussion was also held regarding the Village Fee Schedule, as well as the Planned Unit Development (PUD) and its relation to the solar array application.

Eric Toftegaard answered questions and discussed the results of the FY 22-23 Deer Management Program.

Deputy Fire Chief Gregory Parker discussed the FEMA grant awarded to multiple fire departments in the Town of Dryden. Discussion was also held regarding upcoming repairs at the Fire Hall, as well as the status of the structure on 15 Railroad Street.

Trustee Ortolano motioned to approve the Public Works Report. Trustee Cuykendall seconded the motion. All members present voted aye. Motion passed.

Treasurer: Trustee Cuykendall motioned to approve the Treasurer Report. Trustee Radford seconded the motion. All members present voted aye. Motion passed.

Code Enforcement: Code Official Casey Drader discussed the status of Life Safety Inspections within the Village. Discussion was also held regarding the Land Use Law and the site plan review requirements for wells and septic systems. Trustee Ortolano motioned to approve the Code Enforcement Report. DEC / WWTP: Discussion was held regarding the Capital Improvements Plan for the GHD Engineering Study as well as the deadlines for the Short Term Corrections Plan. Discussion was held regarding the Hazard Mitigation Grant, the Village was awarded a grant from FEMA for the installation of a generator at the sewer plant.

Village Speeding: Trustee Cuykendall discussed his research regarding the process to lower Village speed limits. Due to constraints and costs involved in the process, consideration of the matter is postponed.

Door to Door Soliciting: Discussion was held regarding updating the current Solicitation Law. Trustee Fogel will present an updated draft at his earliest convenience.

NY Museum of Archeology - Core Drilling Study: Discussion was held regarding the NY Museum request to drill and collect core samples on a property on Johnson Street. The Village and property owner have agreed to permit the drilling for archaeological core samples.

Deer Management - Renewal: Trustee Cuykendall voted to renew the Deer Management Program for FY 2023-2024. Trustee Radford seconded the motion. All members present voted aye. Motion passed.

Official Village Newspaper: Discussion was held regarding the cost of legal notices for other media outlets. The Village will continue to post notices in the Ithaca Journal.
